Year 10 Parents' GCSE Information Evening

What an excellent turn-out! Thank you very much to all parents and carers who braved Tuesday's downpour to hear how GCSE syllabi and accountability has changed, the implications for your children, and how my colleagues at Clyst Vale are doing everything they can to ensure students succeed despite all the changes and increased demands. There is more rigour in all subjects; closed book exams; more problem-solving and application; more memorisation needed; more exams in total; and no controlled assessments or coursework in most non-practical subjects. Therefore, we are starting GCSE work earlier during Year 9; changing approaches to place more focus on memory and revision; familiarising students with the new exam requirements; and seeking to build confidence to reduce the pressures. It also means that we cannot tolerate learning time being wasted by disruptive behaviour, and I believe that this message is sinking in. As I said at the evening, if you're 47+ and sat O-levels, you will have a pretty good idea of the current demands on GCSE students.

Education Funding Update

A mass lobby of Parliament will be held on Tuesday 24 October to tell MPs directly about the impact of real-terms school funding cuts. While introducing a National Funding Formula is a positive move, the amount of funding going into education is simply insufficient.

The additional £1.3bn announced by Justine Greening in July was a step in the right direction, but schools have already suffered huge real-terms cuts and the additional funding is nowhere near enough to prevent the need for further savings. The £1.3bn is also one-off funding split over two years, recycled from elsewhere in the education budget. All it achieves is reduce the real-terms cut from 6.5% to 4.6% between 2015 and 2019 and does nothing to address the woefully inadequate level of funding for 16-19 education .

What can parents do? Write a letter or send a short e-mail to your local MP based on this paragraph, previous Newsletters or letters. I assume that many parents believe that the government must invest more in the future of our young people, and recognise that this issue contributed significantly to the General Election result. I also assume that many parents will expect to see a better deal for schools and colleges in the Budget on 22 November.

Deep Learning Day

For parents new to Clyst Vale, DLDs are days on which the normal timetable is suspended to allow students to pursue activities or themes across a whole day (or sometimes half a day) to "deepen" their learning on that topic. DLDs also allow some curriculum-based trips without disruption to the normal timetable. Further, especially in Years 10 and 11, DLDs are an important delivery mechanism for Course 42, i.e. health, safety, sex and relationships, and careers education. Your child's experience will depend which year s/he is in: Year 7 will have two activities from Languages and Maths; Year 8 Literacy; Year 9 Developing World; Year 10 and 11 Course 42 and Careers; Year 12 will attend "Learn2Live", a fairly harrowing personal safety course aimed at 17-18 year olds. Unless advised otherwise, students should always assume that they are in normal College uniform for DLDs.

Spanish Visitors

We have now said "adios" to thirteen students from Vigo in Spain, who we have been hosting as part of their visit programme to the UK. Our visitors were very impressed with Clyst Vale and appreciated the learning environment, as well as the opportunities that we offer to our students; education is somewhat different in Spain. Special thanks and praise go to our Year 10 "buddies" who escorted our visitors to lessons.

Autumn Safety

Once again, we are pleased to support Devon and Cornwall Police's "Autumn Safety" campaign, and you should have received a letter via the College gateway. The combination of clocks going back and causing darker evenings, Halloween, and fireworks all contribute to an increased risk to safety and of anti-social behaviour. We will, of course, be reinforcing these key messages of keeping yourself safe and respecting your local community, especially the old and vulnerable.

Skirt Length

Just to give notice that we will be having another war against certain skirts after half-term. There are too many skirts which are way too short, especially in Years 9-11. Further, many of these are of stretchy material, making them very tight. As I've said many times before, a skirt is clearly too short if a girl cannot with due dignity get out of a car, alight from a bus, sit in assembly or on the field, get up from a bench in the Giraffe House, or walk up stairs. Half-term is an excellent opportunity to buy a more appropriate skirt.

Since leaving Clyst Vale in 2006 with A grades in English and Art A-level, Jez has had an amazing career in art, design and graphics. The Campaign is about reducing the anti social behaviour associated with Halloween on 31st October, Bonfire Night on 5th November and the days leading up to them. Thanks to the cooperation from parents and carers in the past and also with the assistance of local retailers and the Police, I am pleased to say that over the years our campaign has been successful and reports of anti social behaviour in East Devon at the above times of the year, still remain relatively low.


Having said all that there continues to be some incidents involving the throwing of eggs and flour and problems concerning loud fireworks and the misuse of them. It goes without saying that such incidents cause alarm and distress to certain members of the community. Some older and also other vulnerable people do get very frightened by this type of behaviour and again it cannot be emphasised too much the fear even one or two incidents can cause. Many of you have parents, other relatives and friends who are elderly and I feel sure that you would not want them to be alarmed by such irresponsible acts. Once again I ask you to advise your children that this type of activity is anti social as it is likely to cause unnecessary alarm and distress.

'Trick or Treat' under adult supervision is of course acceptable but please be sure of your children's whereabouts if they engage in this activity. Many people still don't like answering the door to callers taking part in this and often get both frightened and concerned.

Police Officers do pay particular attention at this time of the year in order to monitor behaviour but I hope that if we all work together reports of anti social behaviour will continue to remain low.



- Travel from College to resort and return journey (luxury 49 seater coach fitted with seat belts), plus ferry, together with use of coach whilst in resort

- Full area lift pass
- Full insurance (including 24 hour Medicare, ski breakage and snow guarantee)

School Transport

- 1. Clyst Vale supports the (DCC) Devon County Council's "No Pass No Travel Scheme" that operates on transport to and from this College.
- 2. Only students who show a valid travel pass to the driver **on every journey** will be allowed to travel. Students must travel on the vehicle indicated on their pass.
- 3. Please ensure that your child has their travel pass before they leave home every day.
- 4. Please ensure that your child knows what to do in the event they are not allowed to travel or the bus does not arrive (e.g. because of breakdown or traffic conditions or severe weather). College attendance is very important and it is best to be prepared for any of these eventualities.
- 5. DCC will carry out regular pass checks throughout the year.
- 6. Drivers are not allowed to carry passengers who cannot show a valid pass.
- If your child loses their pass during the day they should go to the AtHoS offices to ask for a 10 day temporary pass. Replacement passes cost £5 each and can be ordered online, or by sending a cheque with a replacement form.

COLLEGE DRESS

Clyst Vale aims to maintain a simple pattern of College dress to promote a clear sense of identity and enable students to come sensibly dressed, at reasonable cost, for a range of learning activities. If a student is improperly dressed, correct uniform will be provided for that day or the student may be sent home to change his/her clothing, at the discretion of the Principal.

If parents are in any doubt about the suitability of an item of uniform they should check with the College before buying it.

Uniform for all Students in Years 7 to 11

- White collared shirt.
- School colour tie.
- Clyst Vale V-neck jumper with School colour logo.
- Trousers should be plain, black, formal and full length. This means no jeans, leggings, chinos or any trousers with rivets or studs. Trousers must be worn on the waist.
- Skirts should be plain black, and may be worn just above the knee. Skirts must be A-line or straight, but not stretchy or "skater" style.
- Knee length black tailored shorts may be worn in the summer.
- Black sturdy shoes or <u>all black</u> trainers.
- Clyst Vale reversible jacket or other outdoor coat.

Main uniform can be purchased from SWI online shop or Thomas Moore.

PE kit is only available from SWI online shop.

The reversible jacket is only available from Thomas Moore.

- Eyebrow jewellery, facial, tongue, nose and lip studs are not permitted.
- Leather jackets, all denim garments and all hoodies are not permitted.
- Hats should not be worn indoors.
- Outer coats should be predominantly plain in colour and without large logos.
- A plain white t-shirt or vest may be worn under the shirt.
- On health and safety grounds, shoes should be appropriate for a work place. Flipflops, open toes, Uggs, Dr Martens (or equivalent) are not permitted.
- Jewellery may be worn, providing it is not excessive or potentially hazardous. However, it is a legal requirement that all jewellery must be removed before undertaking sporting activities. It is the responsibility of the wearer to do this.

The Principal, in consultation with the Governors of the College, will decide on the suitability of the appearance of a student attending the College – extreme hair styles, of either cut or colour, are not permitted.
